Sean Wood presented a quote from Brad Harris Construction for widening the area near concession stand with additional concrete. Small portion quote is \$7373.00. The whole area quote is \$18,167.00. No action taken at this time.

After discussion, it was decided that a damage/security deposit will be received from each ball team rather than each ball team organization using the SBRD2 ball fields. Sean Wood made motion to accept this recommendation. Troy Bollich seconded. All in favor. None opposed.
